NOTIFICATION

In exercise of the powers conferred by proviso to Article 309 of the Constitution of India, the Governor, Himachal Pradesh, in consultation with Himachal Pradesh Public Service Commission, is pleased to make the following rules further to amend the Himachal Pradesh Subordinate Services Selection Board, Section Officer / Assistant Registrar, Class.I (Gazetted) Recruitment and Promotion Rules, 2001 notified vide this Department Notification of even number dated 24-5-2001, namely: -

Short title and Commencement 1. (1) These rules may be called the Himachal Pradesh Subordinate Services Selection Board, Section Officer / Assistant Registrar, Class-I (Gazetted) Recruitment and Promotion (First Amendment) Rules, 2007.

(2) These rules shall come into force from the date of publication in the Rajpatra, Himachal Pradesh.

Amendment of Annexure "A" 2. In Annexure "A" to the Himachal Pradesh Subordinate Services Selection Board, Section Officer/Assistant Registrar, Class-I (Gazetted) Recruitment and Promotion Rules, 2001, for the existing main provision of column No.11(i), the following shall be substituted, namely: -

"(i) By promotion from amongst the Superintendent Grade-II who possess three years regular service or regular combined with continuous adhoc service, if any, in the grade failing which by transfer on secondment basis from amongst the incumbents working in other Departments / Boards / Corporations in the same pay scale."
