4. Bonafide Himachali Certificate.

5. If you belong to SC/ST category, Certificate of SC/ST on parental basis.

6. If you belong to OBC category, OBC Certificate on the prescribed format on parental basis valid on the date of applying for the post as well as on the date of evaluation of 15 marks, in support of reservation claimed by you as an OBC candidate. The OBC certificate is valid for one year from the date of issuance.

7. NOC from the Employer if you are in Govt. / Semi Govt. service.

- 8. In case you have claimed reservation as WFF category then a latest certificate from competent authority that you are a dependent of freedom fighter.
- 9. In case you belong to BPL/EWS family you should bring the necessary certificate on the prescribed format duly issued by competent Authority. As the BPL certificate is valid only for six months from the date of its issue, the certificate should be valid on the date of applying for the post as well as on the date of Evaluation of 15 marks
- 10. The benefit of reservation under EWS can be availed upon production of an income and Asset Certificate issued by the Competent Authority i.e. DC/ADC/ADM/SDO (civil) of the area where the candidate and /or his family resides; and revenue officer not below the rank of Tehsildar. The candidate is required to furnish the valid certificate including the old certificate of the time of filling the Application as well as on the date of Evaluation.
- 11. The Candidate belonging to un-reserved BPL category is not required to submit Income & Asset Certificate. He shall be treated as eligible for EWS reservation on the basis of valid BPL certificate issued by the Competent Authority and supplemented by non SC/ST/OBC Certificate. If any BPL Candidate applies for the post reserved for EWS category he/she shall have to submit a Valid BPL certificate countersigned by the Block Development Officer and also non-SC/ST /OBC certificate issued by the competent authority. The certificate should be valid on the date of application as well as on the date of evaluation.
- 12. In case you are a Ward of Ex-serviceman and the posts are reserved for Ward of Ex-serviceman then you are required to bring certificate following on prescribed formats download able from the website of the Commission

(i) Ward of Ex-servicemen certificate from Deputy Director Sainik welfare.

(ii) Latest Annexure 'A' issued by the Patwari /pradhan and countersigned by the Tehsildar/Naib Tehsildar.

(iii) Latest affidavit on annexure 'B' by the candidate.

13. In case you are a Ward of Ex-serviceman & the posts are not reserved for Ward of Ex-serviceman then you are required to bring ward of Ex-serviceman certificate in support of fee relaxation.
