

HIMACHAL PRADESH RAJYA CHAYAN AAYOG, HAMIRPUR

PRESS NOTE

Himachal Pradesh Rajya Chayan Aayog today declared the final result for the recruitment of 66 posts {Gen(UR)-16, Gen(EWS)-07, Gen(WFF)-01, Gen(WXSM)-08, OBC(UR)-11, OBC(BPL)-02, OBC(WXSM)-02, SC(UR)-11, SC(WXSM)-03, ST(UR)-03, ST(BPL)-01 & ST(WXSM)-01} of **Steno Typist (on contract basis) Post Code: 928** requisitions for which were received from the various Departments/Boards/Corporations and were advertised vide advertisement No. 37-3/2021 dated 01.12.2021.

In response to this advertisement, 16223 applications were received, out of which 13924 applications were provisionally admitted for written objective type screening test.

The Written Objective Type Screening Test was held on 29.05.2022 in which 7724 candidates appeared and 6200 candidates remained absent.

Based on the performance in the Written Objective Type Screening Test of 100 marks, 1153 candidates in the ratio of 1:20 were called for Shorthand and Typing Skill Tests conducted w.e.f. 1st August to 20th August, 2022 in which 504 candidates appeared and 649 remained absent. Out of 504 candidates, 107 candidates qualified the shorthand & typing skill tests and all of them were provisionally short listed for further selection process i.e. document verification process on the basis of merit of written objective type screening test as per the Government Notification No. *Per(AP.B)B(15)-11/2018 DATED 04.05.2022*, which was conducted w.e.f. 10 & 11-03-2025.

Subsequently, 78 candidates appeared in document verification and 29 remained absent. The candidature of 01 candidate bearing Roll No. 928009278 has been rejected by the Aayog due to underage. The Aayog has compiled the result of 66 posts of Steno Typist Post Code: 928. The candidates bearing following Roll Numbers have been declared successful;
